1. Welcome and Introduction

The Convener advised that an Estates Committee Seminar had been arranged to consider the University Digital Strategy and Digital Estate. This was to allow sufficient time for a full update and discussion on the item.

A suite of documents had been circulated to the Committee and a comprehensive consultation exercise undertaken. The Seminar would provide an opportunity for questions and comments which could then be incorporated into the documentation as the Strategy progressed to other University Committees.

2. University Digital Strategy and Digital Estate

The report submitted to the Committee Seminar set out:

- A high-level outline of the University Digital Strategy and Digital Estate and the actions required by Committee members;
- An overview of the University Digital Strategy; and
- Plans for the Digital Estate, including major Digital Estate projects, a Heatmap of major digital estate risks and a proposed digital Estates roadmap. The digital estate is a key enabler of the University Digital Strategy.

A number of background papers were also available including:

- A communications approach;
- The Digital Strategy Implementation Overview;
- A guide to implementation; and
- The full Digital Strategy

In addition, the Vice-Principal, Chief Information Officer and Librarian to the University provided a presentation to the Seminar.

The Committee Seminar had a thorough discussion on the presentation and the accompanying documentation. Key points raised included:

- A comprehensive review of the Digital Estate had been undertaken;
- There had been a high level of ownership and involvement from the Provost, Colleges and Professional Service Groups during the consultation process;
- The Strategy and Plan provided an opportunity to ensure that decisions related to the Digital Estate were informed and that forward plans were in place;
- Members were supportive of the presentation specifically the Infographic overview of the Strategy and the heatmap;
- The vision statement did not include enough detail regarding keeping information safe and secure and consideration could be given to adding this;

- Consideration of the cultural change and behavioural aspects related to the Strategy including people skills and the appetite for change;
- That projects within the Strategy may provide savings and how would this be expressed and captured;
- The consequences of implementation of the Strategy including the possibility of a requirement for additional data centres, alignment to existing University Strategy and the potential requirement for additional Strategies e.g. a University Artificial Intelligence Strategy and an overall University Data Strategy; and
- The impact of the Strategy and consequences of next steps should be highlighted.

The Committee Seminar noted:

- That the Colleges were supportive of the Digital Strategy
- There were 4 main themes; Behavioural and User Experience, Owner of Strategy, Investment Efficiency and what other investments have to align to the Strategy
- Discussions on how to resource the Digital Strategy across the University to include executive sponsors, hold appropriate training and general business as usual requirements were being held.

It was highlighted that the Digital Estates heatmap and Strategy covered 77 largest and most material Digital Estates platforms, out of a total of over 1100 Digital Projects and queried the level of resource required for smaller projects that were not covered by the strategy. It was agreed that the Vice-Principal, Chief Information Officer and Librarian to the University would estimate the size and cost of the remaining smaller projects.

Action: Vice-Principal, Chief Information Officer and Librarian to the University

It was agreed that comments from members should be incorporated into the Strategy before it progressed to Knowledge Strategy Committee, Policy and Resources Committee and University Court. The Seminar was supportive of the Strategy and commended the work that had been undertaken. It was agreed to recommend the draft roadmap, of the Digital Estate, for onward approval to Policy and Resources Committee and University Court.
